# **Parks Victoria Mooring Permit Information**

# Port Phillip and Western Port

Parks Victoria manages the Local Ports of Port Phillip and Western Port on behalf of all Victorians. To improve safety for all port users, security of vessels and to protect marine habitat all moorings require a permit issued by Parks Victoria prior to installation in accordance with the Port Management (Local Ports) Regulations 2015.

### Who needs a permit?

A Mooring Permit is required if:

- You wish to install mooring tackle, <u>for any length of time</u>, within Port Phillip or Western Port, or
- You currently have mooring tackle installed in Port Phillip or Western Port, but do not have a Mooring Permit issued to you by Parks Victoria.

Mooring Permits are renewed every 12 months if you comply with the terms and conditions. Not complying with permit conditions may result in cancellation of your permit.

### Where can mooring tackle be installed?

Set-aside determinations where mooring installations are permitted exist within the Local Port of Port Phillip and Western Port. There are 42 mooring ground areas within Port Phillip and 24 within Western Port.

Flinders Tender Moorings: For safe, efficient management of the local port, new applications or transfers will <u>NOT</u> be considered.

# How do I choose a suitable location for mooring tackle?

Applicants should engage an Authorised Mooring Contractor to identify a suitable location for the mooring installation <u>prior</u> to applying for a Mooring Permit.

The Authorised Mooring Contractor will:

- Assess your proposed site,
- Provide proposed GPS coordinates for the installation, and
- Determine mooring tackle specifications for your nominated vessel at your proposed location.

The maximum vessel length for moorings is 15 metres.

# How do I apply for a permit?

To apply for a permit, a New Mooring Permit application from parks.vic.gov.au/water-management/moorings-andberths/annual-moorings-and-berths/applying-for-a-mooringpermit must be submitted to Parks Victoria for approval.

The application must include proof of ownership of the nominated vessel and if required, a Standard Identification Buoy Order.

# What fees apply?

# When can mooring tackle be installed?

Once the New Mooring Permit application is approved and payment of fees have been received, you will be issued a Mooring Permit. **Mooring tackle cannot be installed by an Authorised Mooring Contractor until the Mooring Permit has been issued.** 

The permit holder must supply a current and compliant Mooring Report and Mooring Condition Report to Parks Victoria, completed by an Authorised Mooring Contractor, for the installation of the mooring tackle <u>within 28 days of installation of the mooring</u>.

# When can I put my vessel on the

#### mooring?

The mooring permit holder can choose if and when they wish to moor their vessel on their mooring, throughout the duration of the Mooring Permit. It is <u>not</u> a requirement that the vessel occupy the mooring at all times. Mooring permit holders should consider removing vessels from moorings if adverse weather conditions are forecasted.

# When does the mooring tackle require inspection?

All mooring tackle must be inspected by an Authorised Mooring Contractor every 12 months. A complaint Mooring Report from the inspection must be submitted to Parks Victoria.

Mooring Permit holders are encouraged to contact an Authorised Mooring Contractor at least 6 weeks prior to the mooring tackle inspection due date to ensure the inspection can be conducted on time.
